So let's think about what it means to preserve historical and cultural legacy in the framework of the program "Poland-Belarus-Ukraine 2020". First of all, this means to keep that knowledge that the direct carriers have.

The main problem of the border area:

- The existing border for dozens of years destroys the bonds of history and culture because of this social connections are breaking .that affects hundreds of families of different generations living on the border territories.

We plan to organise local public meetings between residents of the border areas of Poland and Belarus. At these meetings we plan to record all the stories of life on the border territory. They will communicate, that means that for our target group we will formally "remove the border".

Our project is unique in the framework of the "Poland-Belarus-Ukraine" program.

The result of the project will be the preservation of the history and experience of previous generations and the transfer of this experience to the next generation.
